Part time contract (19hours per week).

JOB DESCRIPTION/RESPONSABILITIES

- Collaboration with the research allergist in charge of the study in the following (but not limited to) tasks: reception of patients, skin prick tests, blood extractions, installment of iv lines, monitoring vital signs, lung function tests, oral food challenges, treatment of adverse reactions; Follow up of patients, schedule appointments for the research related activities; Labeling, storage and shipment of biological samples; Data entry in CRF Collaboration with study monitors, principal investigator and staff of the Allergy; Dept. in order to achieve the study objectives; Work under the principles of Good Clinical Practice (GCP)

SELECTION CRITERIA

The applications will be evaluated by a designated Selection Committee (only if they meet the Education and Training Requirements). This Committee will act in accordance to the following criteria:

A) Merit expertise:

1. Training in Good Clinical Practice (GCP) (0-1 points)
2. Experience in clinical research and clinical trials (0-1 points)
3. Experience in management of patients (preferably if in emergency room, intensive care unit, and/or hospitalization) (0-2 points)
4. Experience in Allergy (0-2 points)
5. Training in advanced CPR (0-2 points)
6. Advanced knowledge of Office and Internet (0-1 points)
7. Fluent in English (spoken and written) (0-1 points)

B) Job Interview (only if you have at least 5 points at A) Merit Expertise). Previous labour mobility and personal experience, including the experience obtained in non-standard or informal ways, will be assessed. (0 to 5 points)
